PLEASE READ AND FOLLOW INSTRUCTIONS BELOW

In order for me to work on a Perazzi trigger, my insurance company and attorney are requesting that a Liability Waiver be downloaded from this site, printed, and signed by the trigger owner.

Please print these two pages (front/back) – the reverse page (page 2) is the actual Liability Waiver.

I must have a signed and dated Liability Waiver by the owner of the trigger to be worked on either received before or enclosed with the trigger and/or gun when shipped in for repairs or modification. Without this document, I will be unable to perform any work.

Should you have any questions, please feel free to call or email me with your concerns.

Because I cannot control how an individual handles his/her gun, I will not be held liable for any damage and/or injury caused from a trigger and/or gun that I have worked on.

Your understanding in this endeavor is greatly appreciated.

Please print PAGE 2, **SIGN**, and **DATE** PAGE 2 and then **ENCLOSE** it with your trigger and/or gun, and instructions for the work you wish to have done, or simply drop in the mail or email.
